The Regular Meeting was called to order at 7:30 pm by Mayor Watters who read the "Sunshine Statement" indicating the meeting was being held in accordance with the Open Public Meetings Act. He then led the Flag Salute.

ROLL CALL

Also present were Township Attorney Wade Baldwin, Acting Township Clerk Jo-Ann Ricks, CFO/Tax Collector Judith Curran, Police Chief MacDonough, Deputy Treasurer JoAnn Fascenelli, and Township Deputy Clerk Illena Raffaele.

Approximately 11 people from the public were in attendance.

SWEARING IN CEREMONY

Mr. McGuinness conducted the swearing in of Officer Michael McDonald.

APPROVAL OF MINUTES

April 12, 2023 – EXECUTIVE SESSION

The minutes of the meeting noted above were approved unanimously on a motion by Mr. McGuinness, seconded by Mrs. Mora Dillon.

April 12, 2023 - REGULAR SESSION

The minutes of the meeting noted above were approved unanimously on a motion by Mr. McGuinness, seconded by Mr. Farino.

CLERK'S REPORT

Mrs. Ricks stated no report at this time.

FINANCE REPORT

Mrs. Curran stated no report at this time.

EMPLOYEES' REPORT

Mrs. Fascenelli reported:

<u>Additional Resolution</u> – There is a resolution on the dais that she submitted too late and asked if it could be added to the agenda for this evening. Mayor Watters spoke to the attorney who said it could.

<u>2022 Tonnage Report</u> – She just filed the tonnage report with the State. Not all companies submitted their information, but it's not due until June 15th so we can continue to add to it.

ENGINEER'S REPORT

Mr. Quamme reported the following:

Mt. Bethel Community Center – Bonds are approved by the Township attorney and contracts may be signed. Certificate of Insurance is needed, then can proceed. A few items are to be discussed in Executive Session related to the contract.

Roads – NJ DOT Special Local Aid Grant came out last week. Committee needs to consider which road to do for the special aid and which to do for the normal aid. June 2nd is special aid deadline; normal aid deadline middle of July. Mr. Quamme suggested the special aid be used for the second half of Snyder Road that this grant would see as priority. Mayor Watters said they will discuss roads in Executive Session.

<u>Janes Chapel Road</u> – Waiting for the last punch list item to be completed; contractor can submit the final invoice. Road is entirely done. Local aid inspection came out fine.

<u>Meadows</u> – Phase IIB preliminary work and proof rolling began; should be done by end of this week with their base pavement.

PUBLIC PORTION

Mayor Watters opened the Public Portion of the meeting for public comments.

Joyce Kochis, 173 Cherry Tree Bend Road, requested her road to be paved and signs posted to prevent speeding. Mayor Watters stated her road will be discussed in Executive Session.

Glen Wainen, 10 Country Meadow Road, asked if insecticides were used to treat trees along the roads to keep them from dying. Mayor Watters stated they were not. Mr. Wainen also stated that the tree ordinance on tonight's agenda has no red line version of the older ordinance. Said 45 days is not enough time to get estimates and schedule tree removal. Asked if it was a new ordinance. Mr. Baldwin stated it is a new ordinance.

Scott Reyes, 3 Country Meadow Road, asked if there was precedence for this ordinance to establish a pattern for this ordinance to be written. He stated the Township has trimmed the trees in the past. Mr. Farino stated this was done to clear the roadway so all trucks wouldn't hit them. Mr. Reyes asked what is Code 1.17 and what is the punishment established in that code because it appears to label property owners as criminals. Mrs. Mora Dillon stated it's a fine violation. Mr. Baldwin stated the Zoning Officer will issue summons only if not paid. He also stated an extension can be requested. He then read the definition of the code that mentions imprisonment. Mr. Reyes stated precedence is that the Township has always taken care of the trees.

Andrew Gewain, 1 Country Meadow Road, asked what defines a dying tree. Asked if there are exceptions like trees by power lines since JCP&L usually takes care of them. Ordinance states it's the property owner's responsibility. Mr. Baldwin stated JCP&L takes care of those trees. There are 45 days to remediate and an extension can be requested. The Township will let residents know if a tree needs to be trimmed or removed. Mr. Gewain asked for the ordinance to be clearer. Mr. Baldwin stated the ordinance is all inclusive of tree maintenance.

Mr. Wainen asked who to contact for an extension. Mr. Baldwin stated residents will receive a zoning notice with that information.

Carol Thompson, 510 Rt. 57, stated the court hearing was held yesterday. Judge stated to operate business behind the fence. Must comply with resolution until the trial that's set for September. Violations to be issued on a daily basis for non-compliance. No attempt so far to comply. Mr. Baldwin suggested Mrs. Thompson issue her own complaints. Zoning Officer is part time and not able to issue violations, he suggested she contact the police. LUB statute determined violation. Township will continue acting as it has. Mrs. Thompson stated the judge directed enforcement.

Joe Toscano, Rt. 57 Auto, stated the court date is September 26th and that the resolution is illegal that's why they are having a trial.

Jon Kastra, 45 Blau Road, concerned about the 18 wheelers on Blau Road. Wants signs; it's a safety hazard for kids. At least a dozen 18 wheelers are on the road each week. If signs are posted, residents can call police. Chief MacDonough stated traffic officers will do a target enforcement. Mr. Kastra said there are 10-ton limit signs. Asked for sign for no commercial traffic. Mayor Watters stated the County is helping us work on it because a lot of the roads are County roads.

Mr. Kastra also asked if the board [Committee] can institute a bi-law for any Township purchases over \$100K to be voted on by township residents. He asked when \$560K was voted on and approved for the community center. The library was voted down 2:1. Mrs. Mora Dillon stated 75% was from the Historic Community by the County.

Patricia Kinney, 140 Cary Road, stated the residents voted in the Committee. They are keeping the township alive and working well.

Mayor Watters asked for further comment from the public, seeing none, the Public Portion was closed.

WHEREAS, the CFO has adjusted Mr. Cregar's salary for the most recent pay period ending April 14, 2023;

WHEREAS, Mr. Cregar should be paid retroactively as follows:

Old Salary = \$51,300, New Salary = \$57,713, difference of \$6,413.00 yearly;

Difference in bi-weekly pay of \$246.65

Pay period from February 1, 2023 to February 10, 2023 – (\$246.65/10), pay period was from January 29, 2023 – February 10, 2023, therefore:

= \$24.66 for 8 days = \$197.28

Difference in pay of \$246.65 for four pay periods - $$246.65 \times 4 = 986.60
